

Website Terms of Use

1. Commitment to your Privacy

- 1.1. Welcome to the Website owned and operated by SA Corporate Real Estate Limited ("SAC"). SAC is committed to protecting the privacy of the user of the Website. SAC values the trust of its subscribers and all others who work with it, and SAC recognises that maintaining your trust requires transparency and accountability in how SAC handles your Personal Information. This privacy policy ("Policy") is incorporated into and is subject to SAC's standard terms and conditions and the general terms relating to the use of the Website.
- 1.2. In performing SAC's services in the ordinary course of business, SAC may collect, use and disclose Personal Information. Anyone from whom SAC collects such information can expect that it will be appropriately and lawfully protected and that any use of or other dealing with this information is subject to consent, where this is required by law. This is in line with the general privacy practices of SAC.
- 1.3. This Policy sets out how SAC collects, uses, discloses, and safeguards the Personal Information it processes in the course of its business.

2. Acceptance of Terms

These Terms take effect as soon as you access the Website and constitute a binding agreement between SAC and yourself. The current version of these Terms will govern both SAC's and your rights and obligations each time you access this Website. If you do not agree with any provision contained in these Terms, you must immediately cease to use the Website. Your failure to do so, and your continued use of and access to the Website, will mean that you have read, understood and agree to be bound in full by the provisions of these Terms. Unless the contrary is specified, these Terms apply whether you use and access either free or paid-for services offered by SAC on the Website.

3. Website Use

- 3.1. By accessing the Website, you warrant and represent that (i) your use of the Website is for lawful purposes, (ii) you are over 18 (eighteen) years of age, and (iii) you can legally conclude a binding agreement with the SAC. You further warrant that you will not contravene any South African or international laws by using the Website, any services offered on the Website or any information provided to you by SAC through your use of the Website.
- 3.2 Except as expressly authorised by these Terms, you may not use, alter, copy, distribute, or transmit any content contained on this Website.

4. Information Use

- 4.1. SAC conducts its business in accordance with all South African legislation applicable and relevant to its business. One aspect of such legal compliance pertains to data protection. SAC values the privacy of your information and will protect your personal information in accordance with all relevant laws and regulations. This includes the Protection of Personal Information Act no 4 of 2013 ("POPIA") and all regulations promulgated in terms thereof.
- 4.2 By using the Website, and thereby accepting to be bound by these Terms, you expressly acknowledge, agree and consent to SAC and our suppliers, or any person authorised on our behalf, using your personal information, for any purpose necessary for you to use the Website, or for SAC to render any service to you via the Website, as provided for in terms of POPIA.

5. Amendments of Terms

- 5.1. SAC, in its sole discretion, reserves the right to amend these Terms at any time. Any such amendments will come into effect immediately and automatically. Whenever SAC concludes any amendments to these Terms, the amended Terms will be posted on this page, together with an indication at the bottom of the page as to the date upon which the Terms were last revised. You agree to review these Terms for any such amendments whenever you visit the Website, and you will be deemed to have done so.
- 5.2 Should you not agree to any amendments of these Terms, you must immediately cease to access and use the Website.

6. Content of Users

- 6.1. There are certain areas on the Website that allow users of the Website to upload questions, data, and other information ("User Content"). As a user, you are solely responsible for the User Content that you upload, display, and / or otherwise make available ("Add") to the Website, and you hereby agree that SAC is only a conduit for the online sharing, distribution and publication of your User Content. SAC will not review or reference any such User Content except as may be provided in the SAC's privacy policy or as may be required by law. Unless otherwise stipulated by law, or unless the contrary is specified in any other Terms and conditions of the SAC, all User Content is owned by the User who adds it to the Website. Subject to the aforegoing two provisos, SAC does not claim any ownership rights in any User Content.
- 6.2 You agree not to Add any User Content that contains any information or content that (i) is not legally permitted; (ii) you do not have a right to make available under any law, or under contractual or fiduciary relationships; and /



or (iii) you know is incorrect and / or inaccurate. You agree that any User Content that you Add to the Website does not and will not violate any third-party rights of any kind.

7. Copyright and Intellectual Property Rights

- 7.1. For purposes of these Terms, "Intellectual Property Rights" means "any and all Intellectual Property Rights of whatsoever nature and form including, without limitation, patents, designs, copyright, trademarks, trade secrets and / or know-how, whether in existence now or whether arising in the future, and including all applications and registrations, renewals and extensions thereof, under the laws of any country, territory or other jurisdiction.
- 7.2 Unless the contrary is expressly specified in these Terms, any and all content and material of whatsoever nature and form contained or depicted on the Website, or incorporated or embedded in any service offered on or via the Website, including, without limitation software, images, text, graphics, illustrations, logos, branding, and/ or photographs ("Organisation Content"), and all Intellectual Property Rights subsisting in such Organisation Content, vest exclusively in SAC. You hereby agree and undertake that you will at no time lay any claim to SAC Content, and / or to any Intellectual Property Rights subsisting in such Content.
- 7.3 Except as explicitly provided herein, nothing in these Terms shall be deemed to create a license in or to any Intellectual Property Rights belonging to SAC, and you agree and undertake that you will not yourself, or through any parent, subsidiary, affiliate, agent or other third party: (i) modify, port, translate, localise or create derivative works of SAC Content, or any part thereof; (ii) by any means whatsoever, decompile, disassemble, reverse engineer or attempt to reconstruct, identify or discover any source code, underlying ideas, underlying user interface techniques or algorithms contained or incorporated in any Organisation Content, or any part thereof, or disclose any of the foregoing; (iii) sell, lease, license, sublicense, copy, market, reproduce, transmit or distribute SAC Content, or any part thereof, including any Intellectual Property Rights subsisting therein, without the express written consent of SAC; (iv) encumber or create any lien or security interest in respect of any Organisation Content or any Intellectual Property Rights subsisting therein; and (v) knowingly take any action that would cause any of SAC Content to be placed in the public domain, or that would infringe any Intellectual Property Rights in SAC Content. Use of SAC Content, and any Intellectual Property Rights subsisting therein, for any purpose not expressly permitted by these Terms is strictly prohibited.
- 7.4 You understand and acknowledge that you may be exposed to User Content that is inaccurate, misleading and / or offensive and you agree that SAC will not be liable for any damages you allege to incur as a result of exposure to such User Content.

8. No warranties

- 8.1. SAC does not make any warranties, representations, statements or guarantees, whether express, implied in law or residual, regarding the Website and any services offered on or via the Website, and these are provided on an "as is" basis. SAC also does not make any warranty or representation that any information contained on the Website or included in any services is appropriate for use in any jurisdiction.
- 8.2 Use of the Website, any Organisation Content and / or any service offered as a part thereof is entirely at your own risk. SAC makes no representations, warranties or conditions about the quality, accuracy, reliability, completeness, or timeliness of any of the aforegoing.
- 8.3 SAC does not assume any responsibility for any errors, omissions or inaccuracies on the Website, SAC Content and / or any service that may be offered pursuant thereto.
- 8.4 Neither SAC nor its shareholders, officers, directors, employees, affiliate companies, agents and advisors ("Indemnified Parties") shall be responsible for, and deny, all liability for any loss, harm, damage (whether direct, indirect or consequential) and / or expense of any nature whatsoever which may be suffered by you and / or any third party, as a result of or which may be attributable, directly or indirectly, to your access and use of (i) the Website, and / or (ii) any information contained on or received via the Website (including any reliance you may place on such information), (iii) any Organisation Content, (iv) any services provided pursuant to the Website.

- 8.6 You hereby indemnify the Indemnified Parties against any loss, liability, harm, damage (whether direct, indirect or consequential) or expense of any nature whatsoever which may be suffered by you or any third party as a result of or which may be attributable directly or indirectly to any of the above or the aforegoing.

9. Indemnity

In addition to the warranties and indemnities set out above, you hereby agree and undertake to defend, indemnify and hold harmless the Indemnified Parties from and against any and all claims, damages, obligations, losses, liabilities, costs or debt, and expenses (including but not limited to attorneys' fees) arising from: (i) your violation of any provision of these Terms; (iii) your violation of any third party right including, without limitation any Intellectual Property Right, or other property or privacy right; or (iv) any claim that the User Content caused damage to a third party. All indemnity provisions set out in these Terms will survive termination, modification or expiration of these Terms.

External links may be provided for your convenience; however, SAC makes no representations whatsoever about any third-party website or its content. Use or reliance on any external links provided is entirely at your own risk. It is your responsibility to ensure that you obtain all information relevant to making a decision and that you read the privacy and security policy displayed on any third-party website. SAC has no control over such third-party websites and will not be liable for any loss or damage of any nature that you may suffer, whether directly or indirectly, as a result of your use of third-party websites.

11. Crawlers and Spiders

No person, business or Website may use any technology to search and $\!\!/$ or gain information from the Website without the SAC's prior written permission.

12. Governing Laws

These Terms and all matters or disputes arising from or incidental to them shall be governed and construed in accordance with the laws of the Republic of South Africa and you hereby submit to the exclusive jurisdiction of the South African courts. If any provision of these Terms is found to be unlawful, void, or for any reason unenforceable by a competent court in the Republic of South Africa then that provision shall be severable from these Terms and shall not affect the validity and enforceability of any remaining provisions.



Website Privacy Policy

1. Commitment to your Privacy

- 1.1. Welcome to the Website owned and operated by SA Corporate Real Estate Limited ("SAC"). SAC is committed to protecting the privacy of the user of the Website. SAC values the trust of its subscribers and all others who work with it, and SAC recognises that maintaining your trust requires transparency and accountability in how SAC handles your Personal Information. This privacy policy ("Policy") is incorporated into and is subject to SAC's standard terms and conditions and the general terms relating to the use of the Website.
- 1.2. In performing SAC's services in the ordinary course of business, SAC may collect, use and disclose Personal Information. Anyone from whom SAC collects such information can expect that it will be appropriately and lawfully protected and that any use of or other dealing with this information is subject to consent, where this is required by law. This is in line with the general privacy practices of SAC.
- 1.3. This Policy sets out how SAC collects, uses, discloses, and safeguards the Personal Information it processes in the course of its business.

2. Definitions

- 2.1. In this Policy, in addition to the other terms that have been defined in the body of the Policy, SAC makes use of the following terms:
 - 2.1.1. "Personal Information" means all information which may be considered to be personal in nature or information about an identifiable natural and / or existing juristic person (where applicable) in terms of the Electronic Communications and Transactions Act 25 of 2002 ("ECTA"), the Consumer Protection Act 68 of 2008 ("CPA") and the Protection of Personal Information Act 4 of 2013 ("POPIA"); and
 - 2.1.2. "User, you, your or yourself" refers to any person who makes use of the Website for any purposes whatsoever, whether or not such use is free of charge or paid for.
- 2.2 In addition, unless the contrary is specified, terms that are used in the Policy that are specifically defined in POPIA, are given the meanings ascribed to them in POPIA.

3. What personal information does SAC collect and why?

SAC may collect Personal Information in conducting its ordinary business operations, including through the use of its Website. In processing such Personal Information, SAC at all times ensures that (i) it complies with the provisions of POPIA, and (ii) such Personal Information is used for legitimate business purposes.

4. Obtaining Consent

SAC does not, except where otherwise permitted by law, collect, use or disclose your Personal Information without your consent.

5. Use and disclosure of personal information

- 5.1. SAC operates its Website, and conducts its business in general, in accordance with South African legislation. SAC considers it imperative to protect the privacy interests of data subjects.
- 5.2 In the event that SAC sends Personal Information outside of South Africa (including if such information is hosted offshore), SAC will ensure that it takes all reasonable steps to ensure that it complies with all applicable laws in this regard, including POPIA.

6. Retention of personal information



All Personal Information retained on SAC's database, including such information obtained through the use of the Website, is in accordance with the retention provisions set out in the applicable laws and regulations of South Africa, including those set out in POPIA.

7. Your rights in relation to your personal information

- 7.1. It is important to note that you have rights in relation to your Personal Information.
- 7.2 You have the right to contact SAC at any time to ask SAC to:
 - 7.2.1 confirm that it holds your Personal Information (at no charge);
 - 7.2.2 provide you access to any records containing your Personal Information or a description of the Personal Information that SAC hold about you (subject to payment of a prescribed fee); and / or
 - 7.2.3 confirm the identity or categories of third parties who have had, or currently have, access to your Personal Information (also subject to payment of a prescribed fee).
- 7.3. When you make a request regarding your Personal Information, SAC will take reasonable steps to confirm your identity.
- 7.4 There may be times when SAC cannot grant access to your Personal Information, including where granting you access would (i) interfere with the privacy of others, or (ii) result in a breach of confidentiality. SAC will always provide you with reasons if this is the case.
- 7.5 If you are of the view that any Personal Information that SAC holds about you is incorrect in any way, including that it is inaccurate, irrelevant, outdated, incomplete or misleading, you are allowed to ask SAC to correct it. If you believe that any Personal Information that SAC holds about you is excessive or has been unlawfully obtained, you can ask SAC to destroy or delete it. You may do the same if you think that SAC has retained if for longer than necessary, given the purpose. SAC will do so unless there are good grounds not to (such as that SAC is required to hold it for a period prescribed by any applicable legislation).
- 7.6 It is important, however, to understand that if you withdraw your consent for SAC to use some of your Personal Information, it may affect the quality and level of service that SAC can provide to you.

8. Security

- 8.1. SAC has adopted a security model to protect your Personal Information that complies with generally accepted information security practices and procedures. As part of SAC's security systems, SAC has implemented fire-wall technology, password controls, encryption processes and antivirus software. This is in addition to the physical security measures adopted by SAC to ensure that it takes all appropriate, reasonable technical and organisational measures to prevent (i) loss of, damage to, or unauthorised destruction of Personal Information, and (ii) unlawful access to or processing of Personal Information. SAC has a stringent security policy in place that every officer, employer and supplier of SAC must adhere to.
- 8.2. SAC confirms that it takes all reasonable measures to:
 - 8.2.1 identify all reasonably foreseeable internal and external risks to any Personal Information in its possession or under its control;
 - 8.2.2 establish and maintain appropriate safeguards against any risks that are identified by SAC;
 - 8.2.3 regularly verify that these safeguards are effectively implemented by or on behalf of SAC; and
 - 8.2.4 ensure that such safeguards are continually updated in response to new risks or deficiencies in previously implemented safeguards.



9. Cookies Policy

9.1. This is our Cookie Policy which works hand-in-hand with our Privacy Policy. This policy is intended to provide you with a description of what cookies are, what it will be used for, and a guidance on how to manage it when browsing our website.

9.2. What are cookies?

When visiting our website, small text files, referred to as 'cookies', could be stored on your device. Even though these cookies do not store personal information, it may collect personal identifiers such as your name or email address which allow us to link personal information with your device. This ultimately allows us to recognise your device whenever you visit our website.

9.3. Why the cookies are used?

The cookies on our site are used to:

- 9.3.1 tailor and improve your experience on our website by remembering your preferences, location and device;
- 9.3.2 provide you with content that suits your preferences;
- 9.3.3 ensure advertisements are tailored to your preferences

9.4. Which cookies are used?

Our websites make use of an array of cookies. You are able to remove these cookies at your own discretion. For example, you may decide to delete the cookie as soon as you leave our website or maybe only in a month's time. These cookies will remain on your device until you delete them.

The following cookies are used on our website:

- 9.4.1 essential cookies: This is necessary to ensure the website is able to function properly.
- 9.4.2 functional cookies: These cookies help our website to remember information about you such as your preferences or log-in details e.g. username and password.

9.5 Personal Information

Our cookies collect the following personal information from you:

- 9.5.1 name and surname;
- 9.5.2 contact details (cellphone and email);
- 9.5.3 log-in password;
- 9.6 No other personal information is collected on our website unless you provide this to us by either:
 - 9.6.1 lodging a complaint
 - 9.6.2 providing feedback/ a compliment
 - 9.6.3 your email and other contact details will be processed when logging a complaint or providing feedback/ a compliment.

9.7 Usage and disclosure

The information provided will be used in accordance with the purpose you provided it to us. But the other information specifically provided to us when you for example, submit a complaint, will not be disclosed to anyone outside of SAC. Your personal information will only be disclosed to Third Parties where circumstances are limited and where it is in accordance with the POPI Act requirements e.g. for legal proceedings.



9.8 Website Analytics

SAC website servers will collect the IP address you use to visit our website. This information is then used to analyse specific information such as e.g. determining how many individuals visited the website, how long they stayed on the website etc. Our Third Party, e.g. Google Analytics uses this information to improve SAC's website.

- 9.8.1 Below is a list information collected when visiting our website, which is used for its improvement:
 - 9.8.1.1 When you visited the website [date and time]
 - 9.8.1.2 Your IP address
 - 9.8.1.3 The pages you accessed
 - 9.8.1.4 Your web browser e.g. Google Chrome, Microsoft Edge etc.
- 9.8.2 The website will/does not override any settings on your browser e.g. 'do not track'.
- 9.9 Links to Social Networking Services

SAC makes use of LinkedIn, Facebook, Twitter, You Tube and Instagram to communicate with its clients about its work. These platforms may collect your personal information for its own purpose, should you communicate with us via these platforms.

The above-mentioned platforms may track your use of our website if you clicked on a link to our website through the platform.

9.10. How to delete the cookies?

It is possible, that your browser may be set to automatically accept cookies. However, you are able to manually delete the cookies. We have provided steps on how to delete cookies in Google Chrome below.

- 9.11. How to remove cookies in Google Chrome:
 - o Open Google Chrome.
 - Click on the three dots in the top-right corner of your browser. A drop-down menu will appear.
 - o Click on Settings in the drop-down menu. Settings will open in a new tab.
 - Click on 'Clear browsing data'.
 - o A new tab will open. The tab will be called 'Basic'.
 - o It will provide a list of items you can delete e.g., browsing history, cached images, and files, etc. You need to select 'Cookies and other site data'. Choose the time from when you would like to delete your browsing history e.g., all-time, last hour, etc.
 - o If you have logged into your Gmail account on the device, be sure to sign out, or else the cookies (and possibly history, whichever options you selected) on other devices you are signed into will be deleted too.
 - Once you have selected 'Cookies and other site data' and the time range, you can click on 'Clear data'.

Please note, not accepting cookies may lead to you being unable to access our website or specific content displayed on the website.

SAC will only send you marketing messages when you tick the relevant boxes at certain times when engaging with SAC.
- 10.3 As SAC is not responsible for any representations, information, warranties and / or content on any Website of any third party (including websites linked to this Website), SAC does not exercise control over third parties' privacy policies and the onus is on the User to refer to the privacy policy of any such third party before providing them with any of your Personal Information.

11. Updating of Privacy Policy

You therefore agree and undertake to review the Policy whenever you visit the Website. Save as expressly provided to the contrary in this Policy, any amended version of the Policy shall supersede and replace all previous versions thereof.
